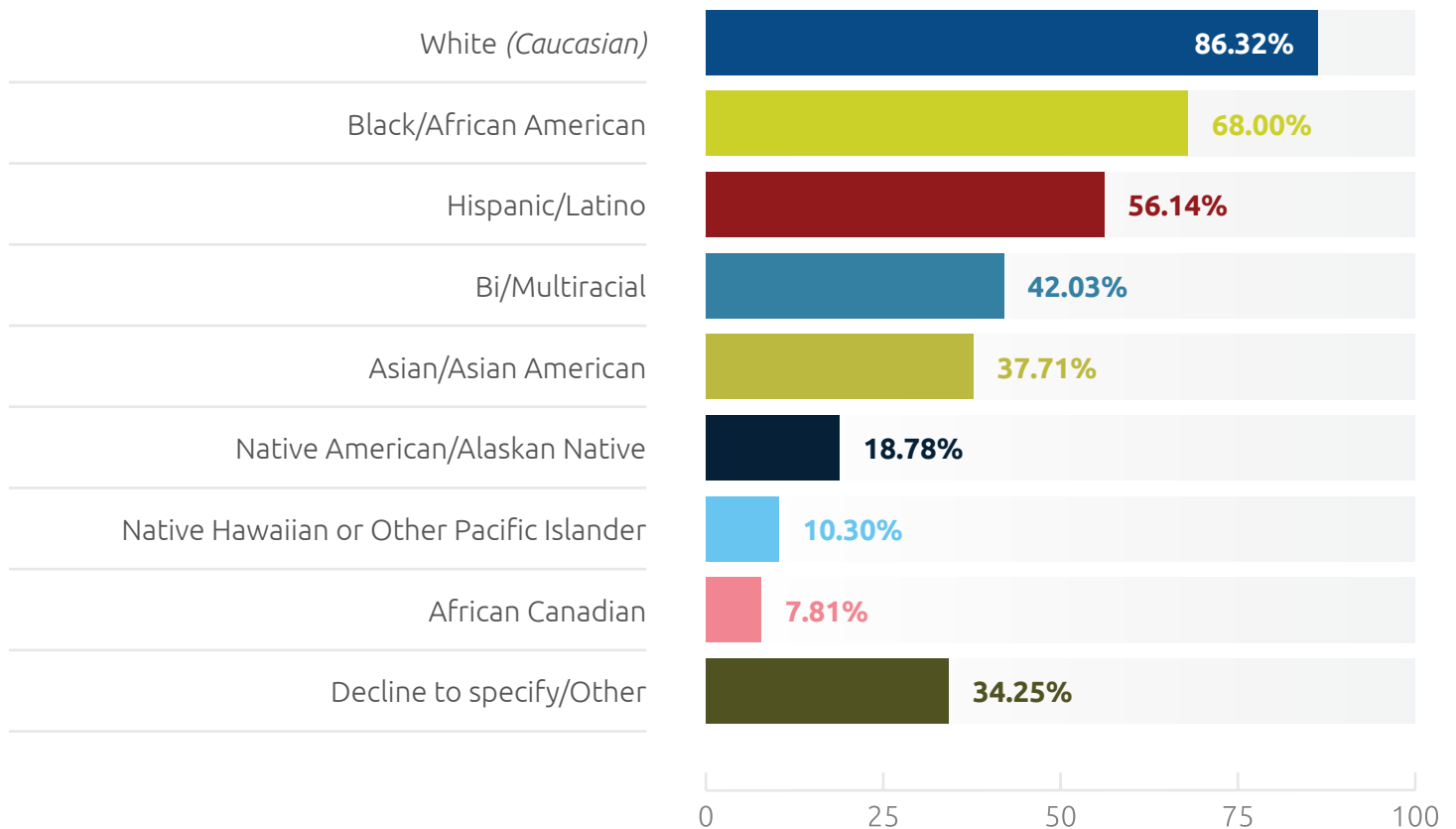

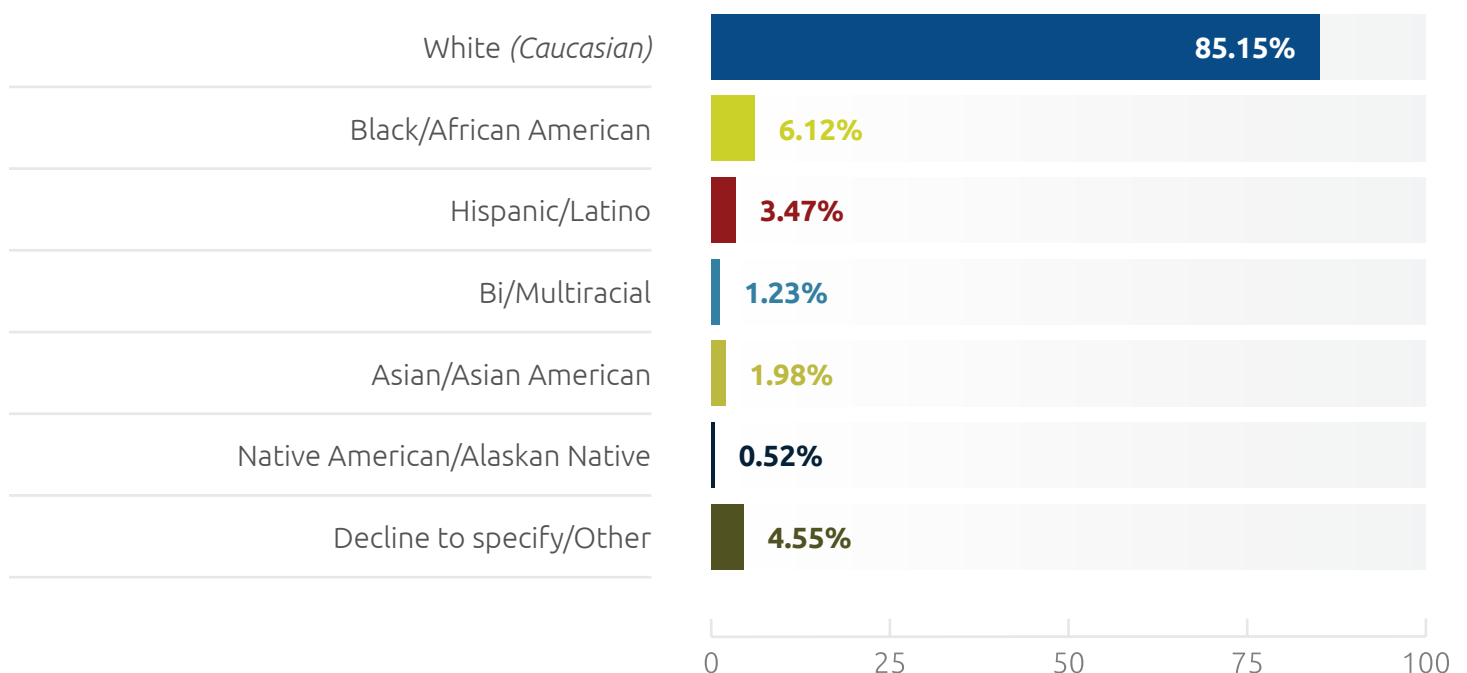

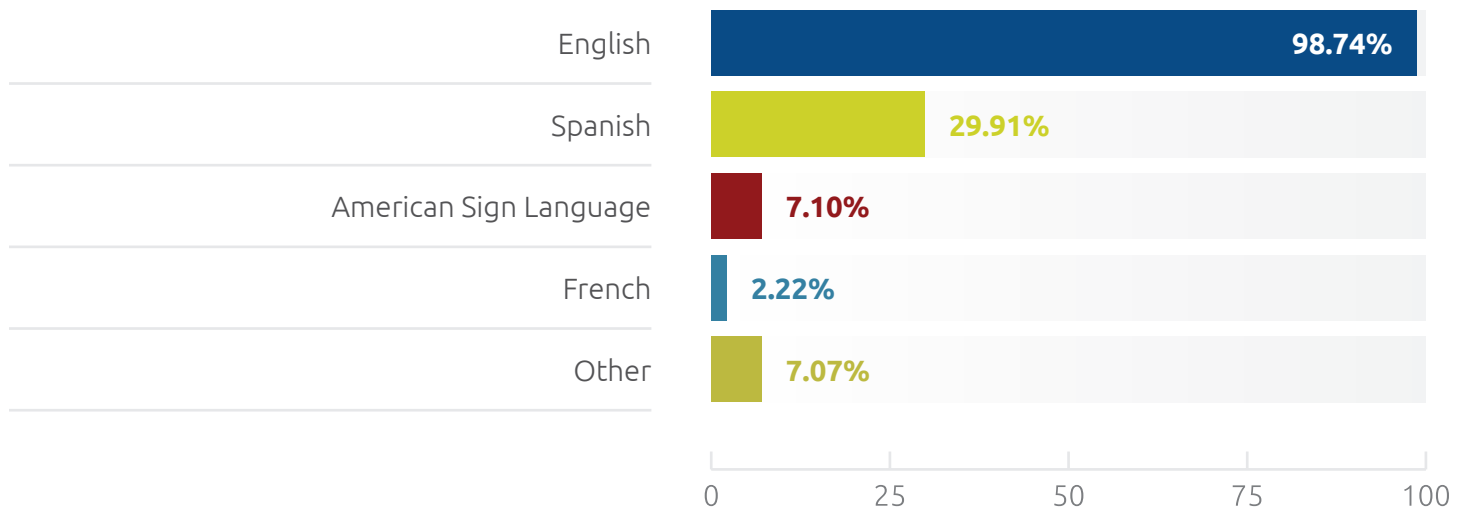
1. What are the racial and/or ethnic origin(s) of clients served within your current practice?



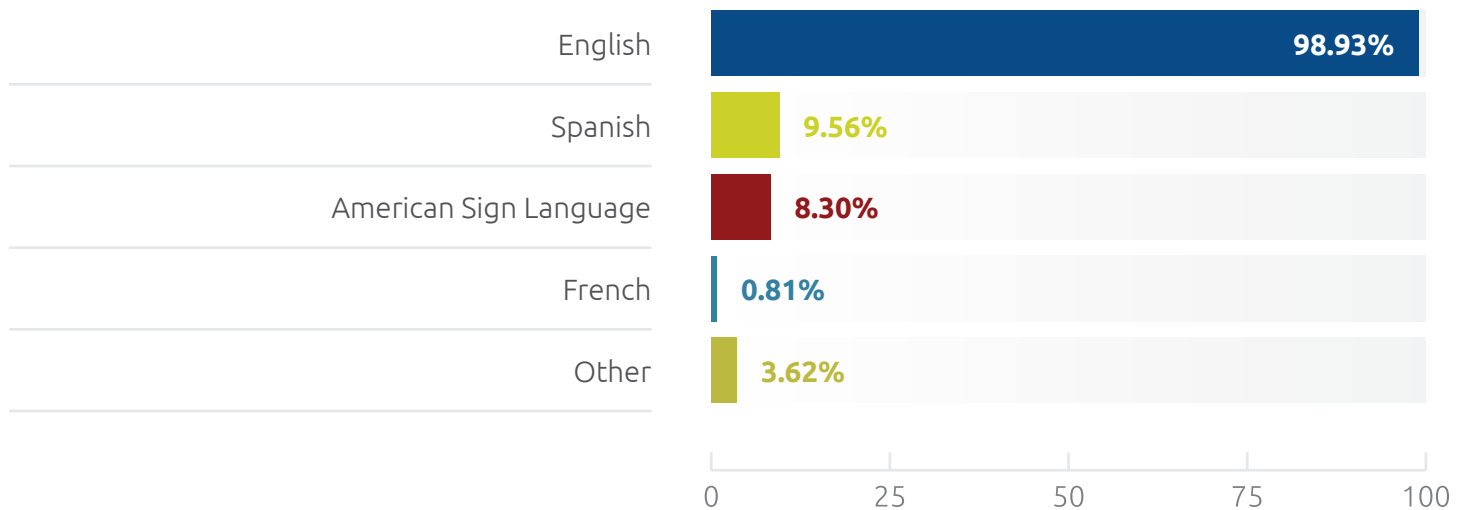
2. How would you describe your racial/ethnic origin(s)?



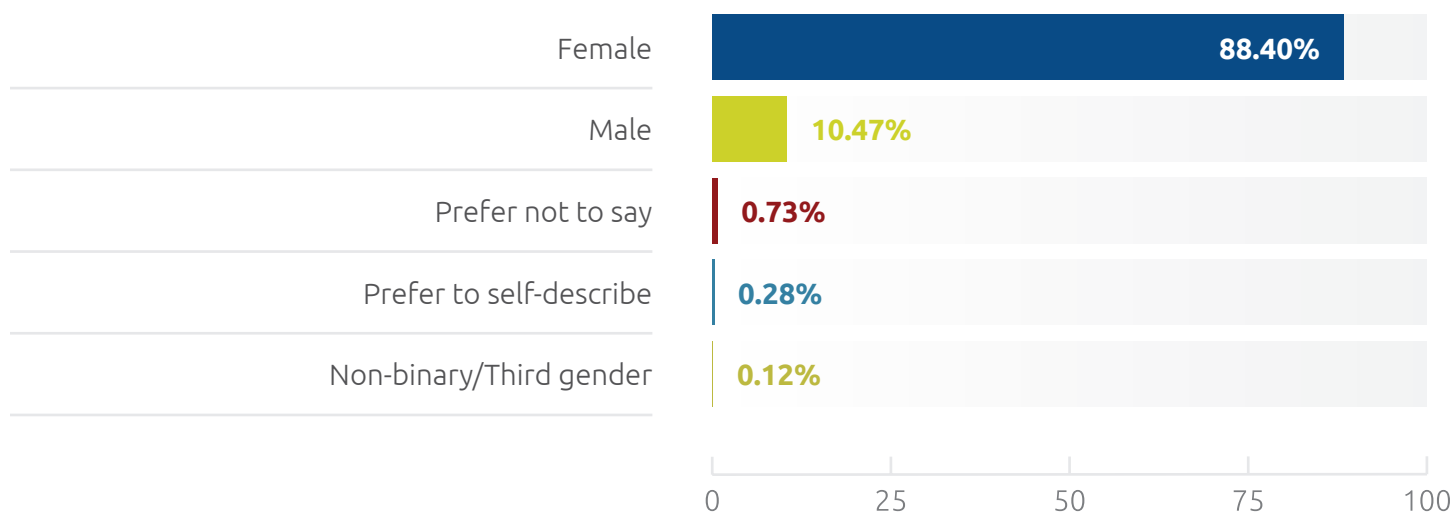
3. Which of the following languages are most commonly spoken by the clients you serve?



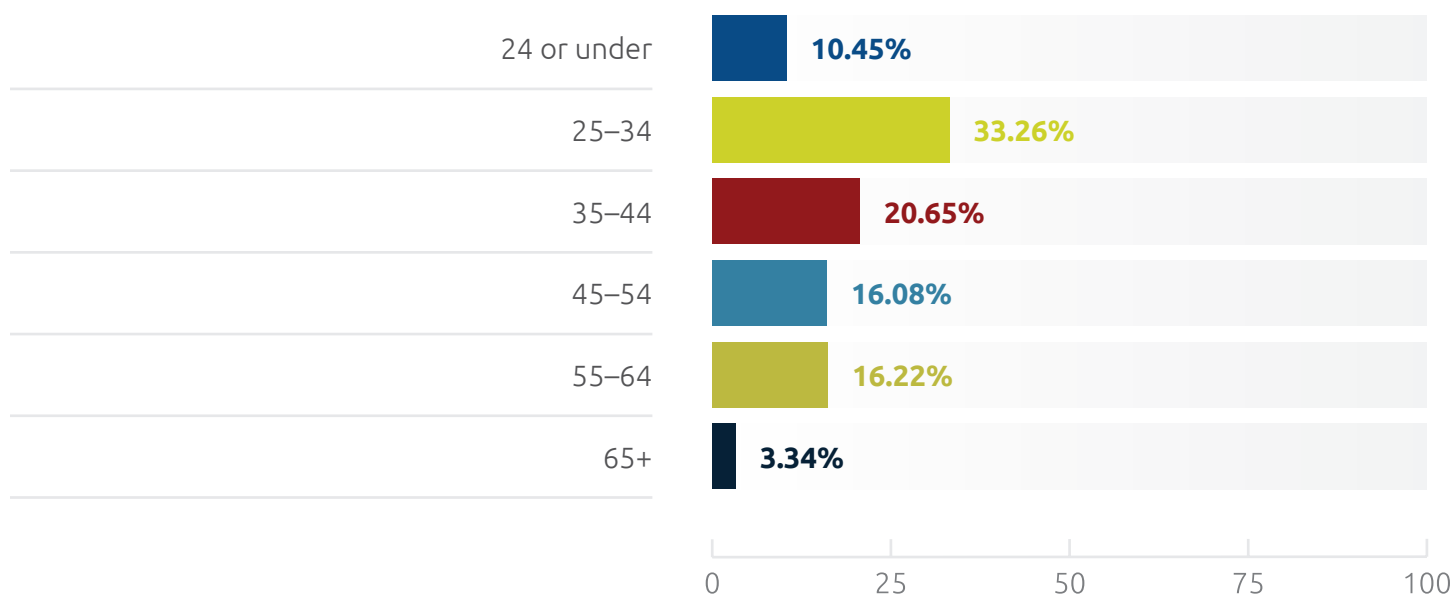
4. What language(s) do you use while providing RT/TR services?



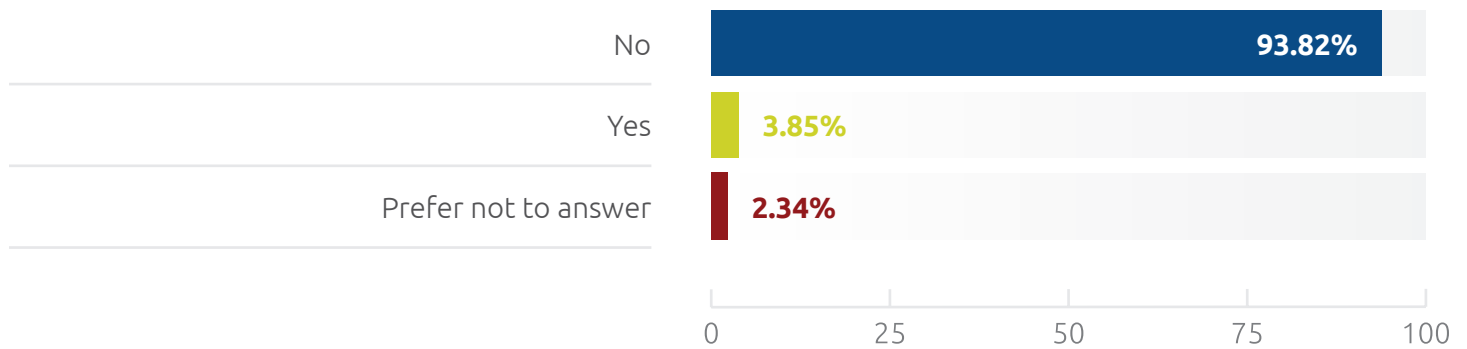
5. What is your gender?



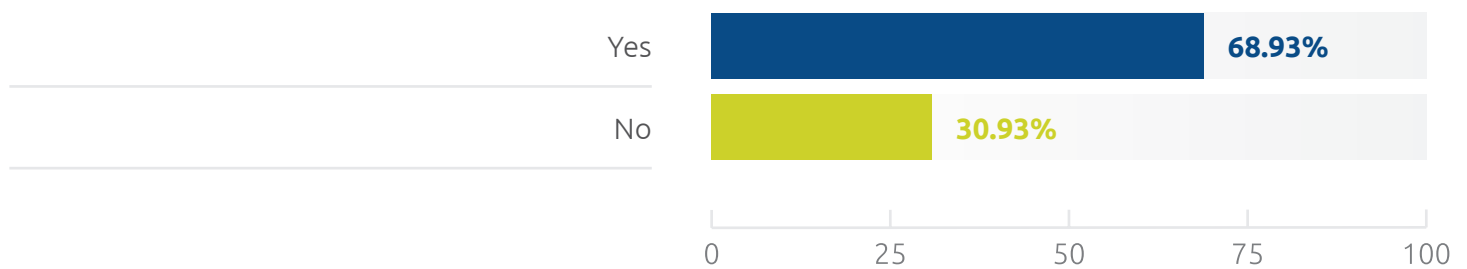
